All exhibitors must have general public liability insurance for \$300,000 per person/\$1,000,000 occurrence and Workers Compensation Insurance as per state statute.

NO COMMERCIAL EXHIBITOR WILL BE ALLOWED TO SET UP WITHOUT SUPPLYING A PROPERLY EXECUTED CERTIFICATE OF INSURANCE.
