## ST-19 FORMS

All exhibitors, whether non-profit or for profit, MUST submit a Minnesota Department of Revenue Form ST-19 (Operator Certificate of Compliance) with the Space Rental Application.

**NO COMMERCIAL EXHIBITOR OR CONCESSIONAIRE  
WILL BE ALLOWED TO SET UP WITHOUT SUPPLYING  
A ST-19.**

This is State requirement that the Beltrami County Fair MUST follow.
